Funding from HC loan for this design work. Once we get tender prices back we will be able to get a handle of costs for funding applications.	
	SIMPK - AP is meeting with other Small Isles and Knoydart next week about the management company. At the CP meeting, CW had queried if NTS could be part of this. This is still a possibility - HC have house on other islands too and so they may also be interested in being part of it.	
	Coroghan Barn - We are still waiting to hear back from planning. Lucy Prins HC Planning came out to Canna last week. It is hoped an update will follow soon.	
	Coroghan Barn - AP is working on the business plan with the bulk of the text cone. AP will issue a draft for comment at the end of the month. AP will then start looking at heritage and regeneration funds to bid for.	
	Mobile Mast - AP met with the team - there are no anticipated problems with the CREEL quote. The company want to get the work over the summer this year. Steve Wade has come back with an updated quote. We are still waiting for DT Gen and Jamie MacIntyre. We need to be aware that the lead times for leases with NTS for the PV's may take some time. b.Senior Care Accommodation	All agreed it would be good to have a place on the island where older people can stay. SICC are talking about this as well. In particular, the new Belford Hospital in FW to include accommodation for visiting families. They have this at Raigmore Hospital in Inverness. It should be a consideration when renovating houses. Care homes on the mainland are not a good solution for islands - being in your own home is more beneficial. This could be extended to include those with disabilities, not just the elderly. Good examples to look at include St. Margaret's Hope in Orkney and projects in the Uists and Applecross.	AP to look at Applecross and circulate link.
c.Multi-purpose building	There are different small businesses on the island and it would be good to have one building that could serve lots of different businesses. There could be a kitchen/ freezer space with bookable rooms/ whole building for a day/ half a day. It is in the development plan and the infrastructure could be focused around setting up businesses. A location for such a building is yet to be determined however all agreed that having sheds with sheds is a good idea e.g. at the compound or at the pier. AP highlighted a new build in the Loch Tay area with food safe finishes. It would be worth getting in touch with them.	IMK to look at Loch Tay development. It was agreed at the meeting that any budget for the borehole should be spent on getting it connected as opposed to installing any monitoring equipment. a.KLCT Esmee Fairburn approach	Kyle of Lochalsh Community Trust have invited IoCCDT to join a joint initiative to put in an EoI to the Esmee Fairburn Foundation which it hopes will fund the organisations for several years for roles, revenue funding and development works. Camus Croise and Knoydart are also included. It is hoped the 4 communities can showcase asset based learning and access extra resources including development, travel and learning. AP raised concerns about capacity here in Canna however if Kyle of Lochalsh is willing to do the initial application work then it might be possible. It would be good to be in touch with these other communities and worth building the relationship with Esmee Fairburn as they like to get alongside community organisations for a good period of time through their funding packages.
